Gladys Eternicka said there is an abandoned house at N4341 Pralle Road with a deep pond with standing water in it, she is worried about misquotes breeding in the warm weather and unkempt lawn. Gladys said she called the La Crosse County Health Dept. The Health Dept view the area, and said the pond is an issue for animals and children if they would fall into the pond they would have a problem getting out, the Health Dept also gave Gladys something to treat the water with to help control the breeding problems for misquotes.

Chairperson Seidel will contact the Financial Institution and make them aware of the problem with the deep pond, and to ask them to have someone maintain the yard.
