### Town of Medary Collaboration - 2011

Town of Medary, with the Town of Shelby, City of La Crosse, and La Crosse County entered into a co-operative agreement to assist in the reconstruction and reopening of Bliss Road. Town of Medary committed to a co-operative agreement totaling \$8,333.00. Medary Residents and friends donated monies in the amount of \$7,145.00 to help off-set the cost, and the town paid the remaining share of \$1,188.00.

## The 2<sup>nd</sup> Medary Family Fun Day - 2011
