Mike Kemp – Shelby Fire Dept.

Shelby Fire Chief Mike Kemp wanted to know if Town of Medary had a Fire Ordinances for: Auto Accidents, Fire Ring permit for Mobile Home Park, and Burn Permits.

Chief Kemp was informed the only Fire Ordinance was for a five day burn permit, which the resident has to call the La Crosse County Dispatch before and after they would burn. Chief Kemp would also request that the Medary residents would also call his cell phone number (780-2845) when starting a fire.

Chief Kemp will send copies of Shelby's Ordinances for Medary Board members to review and pursue if they would like.

Road Striping

If inspection fees were collected seek reimbursement for the costs of \$1,300.00 for the inspections that had been started in 2009 by Richard Grosskopf but, had to be completed by Marvin Horman.
