- Meadow Wood Rd – culvert and water drainage problem - schedule an onsite meeting for August 23, 2011 to inspect the site

- Harter Drive – RW Peters review Harter Drive and said road is in bad shape, schedule an onsite meeting for August 23, 2011
- William Sniff N3102 Vista Court South asked the board why a 20 foot piece of road was missed by his driveway when the road was seal coated. Mr. Sniff was informed the next time Vista Court South Rd is seal coated it would be done.
