# Raj Ramnarace project proposal for house/driveway water distribution catch basin on Keil Coulee Rd, presented by Doyle Pleggenkuhle

Doyle Pleggenkuhle representative for the Ramnaraces explained to the board members the plan for the storm water caught basin that would be installed on the property for the storm water distribution; some work would be done in the Keil Coulee Road right-of-way to create an adequate road ditch for proper drainage. Pleggenkuhle stated they would need to haul 30 loads of fill out; the house would have Fire Sprinklers installed, with driveway retention ponds.

**Motion:** Weibel to approve the driveway plan subject to receiving La Crosse County Erosion Control plan and supplying a surety bond of five thousand dollars (\$5,000.00) to be held by the town for one (1) year. Second Keil ALL AYE

A letter of support from the Town will be sent to Kurt Pederson at Conservation Specialist II at La Crosse County Dept. of Land Conservation.

#### Tom Brown – requesting zoning change for N3119 Smith Valley Rd

Tom Brown presented the board members with copies of a Petition of Support with signatures from surrounding residents, with five (5) conditions:

- No outside storage of equipment, materials, or vehicles, other than employee vehicles.
- No outside signage
- No on-site sales or customers onsite
- Hours of operation: From October through April, hours of operation are based on weather conditions as needed:
  - May through September, 7:30am 6:30pm, Monday –
     Saturday. No Sunday work
- Compliance with Onalaska Fire Department.

Mr. Brown stated that he would operate his Landscaping and Snow Plowing Business at this location on Smith Valley Road subject to these conditions.
