**Motion:** Seidel to approve retaining wall placement at 25 foot distance from center line of Deerfield Road. Chairperson Seidel will send letter informing land owners that any damage inadvertently occurring during road maintenance snow plowing and road mowing is the sole responsibility of the land owner.
