Approval of August 21, 2018 Regular Board Meeting

Motion: Linda Seidel to approve the minutes as presented from the August 21, 2018 regular monthly board meeting. Second: Mike Weibel. All Aye

2019 Fire Protection

Chief Gilliam presented an overview of the 10 year Fire Protection Proposal and how they arrived at the cost to the town. The board will look at setting up a meeting with La Crosse Fire Department and city officials to discuss the proposal.
