Karen Keil reported that she had met with the County Board in regard to concerns from citizen on Rim of the City Road. The area is patrolled 4 – 5 times per day. Suggested solutions included more signage/ lower traffic speeds and radar control (need permit for that). Enforcement of any ordinance seems to be the problem. County updates include discussion for funding the La Crosse Center, La Crosse County Roads, and Funding for the opioid crisis.
