- **N4517 Meadow Wood Rd – drainage ditch**
Sam Brown reported that they have plans to repair
- **Timber Crest Drive West – run off**
La Crosse County Land Conservation Department is aware of the situation and is working closely with the contractor. Project will be cleaned up when the construction is finished.
- **Wash out on Wolf Ridge Ct – near w4923**
Has been repaired.
- **Peters Road** - bump over culvert has been repaired.
- **Meadow Wood** – Pot holes need filling – Sam Brown will check.

- Dennis Naumann – Drainage ditch concerns on Stone Hill Rd – put on hold. Trench from rain running down road creating crevice between blacktop road and cement driveways. Board will look at filling it.

Citizen Concerns

- Home at corner of Meadow Wood Rd and Old Hickory Dr. – Linda will send letter as to 2 dog limit on property. La Crosse Zoning has sent letter to clean up property.
- Resident reported culverts on his lawn at the corner of Timbercrest W and Harter Drive – advised that the town was not planning to replace any culvert in the area – told to contact Onalaska.
- Rim of the City Rd. – Will look into securing street sign more permanently and installing street lighting to deter vandalism.
