Residents had to park at the bottom of Wolf Ridge – concerned for emergency vehicles being able to access homes, Storandt Place and Hidden Springs Rd – not plowed in a timely manner.

- Steve Elsen has changed the battery for the generator. Will change oil in spring.
- Steve Elsen is looking into motion sensors for the lights on the back of the town hall.
