- Deerfield Road washing out – blacktop crumbling - Will do wedging and blacktop. Can clean out water bars and put in bigger rip rap.
- River City Concrete trucks have broken up the blacktop near new house at N2659 Potato Ridge Rd. Linda will look into.
- Sink Hole on Wolf Ridge on Larson property. Caused by X-Cell Energy laying cable lines. Will look at.

### **Citizen Concerns**

- Kay Bevington -upset over Excavating done by Shawn Hanson on his property. Has over 30 degree slope. Has done damage to her driveway with equipment. He has permit from La Crosse County to excavate.
- Will need to make a decision on the tractor.

- Town hall and Park not cleaned up. Will take a more active approach when keys are handed out to remind people to take garbage and clean up when they rent the hall and park.
